St. Patrick's N.S Risk Assessment

1. List of school activities

- Child Safeguarding Statement and DES procedures are made available to all staff. DLP & DDLP to attend PDST face to face training. All Staff to view TUSLA training module & any other online training by PDST. BOM records all records of staff and board training.
- 2. SEN policy to safeguard pupils and teachers in respect of one to one teaching. Table Between teacher and pupil. Glass in window in all SEN rooms.
- 3. Policy on Intimate Care to be reviewed. Intimate Care permission form. Provide training When necessary. Supervision Policy.
- 4. Supervision policy. Agreed procedures in place for use of toilets. Regular reminders for children regarding correct use of toilet facilities
- 5. School implements SPHE, RSE and Stay Safe programme in full.
- 6. Supervision Policy. Arrival and Dismissal supervised by Teachers. Agreed procedures in Place for morning supervision.
- 7. Health and Safety Policy. Code of Behaviour.
- 8. The school has a policy and procedures in place for the use of external sports coaches. Procedures in place regarding Garda vetting before outside coaches are used. Supervision Policy. Teacher present at all times.
- 9. Work Experience Policy. Child Safeguarding Statement.
- 10. Children Protection Procedures. Code of Behaviour. Health and Safety Statement. The School has a yard/playground supervision policy to ensure appropriate supervision

- of children during assembly, dismissal and breaks and in respect of specific areas such as toilets, changing rooms etc.
